Indications

SECURA NO-STING BARRIER FILM is a liquid intended for use as a film-forming product, that upon application to intact or damaged skin forms a long lasting waterproof barrier, which acts as a protective interface between the skin and bodily wastes, fluids, adhesive dressings, drainage tubes, external catheters, and surrounding ostomy sites.

It can also be used on heels, elbows and other areas of the body that are at risk of irritation due to friction damage caused by external surfaces such as linens and mattresses. The product may be used on adults, children and full term infants from one month.

Current therapy

SECURA NO STING BARRIER FILM Wipes are suitable for use with PICO[◊] Single Use Negative Pressure Wound Therapy System fixation strips.¹⁵

Can be removed by common medical adhesive removers, such as UNI-SOLVE[◊] Adhesive Remover Wipes, REMOVE[◊] Adhesive Remover and ZOFF[◊] Adhesive Remover Wipes.^{11,16}
