A unique quadrilobe shape with wide borders allows it to stay in place for longer*¹ and a change indicator lets you know when to change the dressing.²⁻⁴

- Peel the protectors from the centre, without removing completely
- Centre the dressing
- Anchor some of the border on the peri-wound
- You can use your fingers to help the anchoring of the border
